Subject of the Contract 1.1. Under this contract, the Lessor provides the Lessee with a vehicle for temporary possession and use under the conditions specified below. 1.2. Payment can be made in USD, EUR, or KGS (if by cash then make sure the bills are clean, undamaged, unmarked, and in denominations of 20 or higher. Total amount is

2.2. The security deposit is \_\_\_\_\_ USD. This deposit will be refunded in full three weeks after the rental period, provided all terms are met. However, if the Lessee commits illegal actions involving the vehicle (such as theft, unauthorized transfer, etc.), the deposit will not be refunded.

2.3. Early termination by the Lessee results in a 100% retention of the rental fee by the Lessor.

#### 3. Insurance

3.1. The Lessor provides full coverage insurance for the vehicle, with a deductible of \_\_\_\_\_\_ USD per incident. The Lessee is responsible for covering any damage costs up to the deductible amount.

3.2. The insurance company will cover up to 1,000,000 KGS for third-party liability in the event of a road incident.

3.3. Insurance coverage is void if:

- Alcohol is detected in the Lessee's blood (strict 0.0 limit).

- The vehicle is considered to be driven recklessly if it exceeds speeds of 60 km/h in populated areas and 100 km/h on highways.

- The vehicle crosses a solid double line.

- The vehicle runs a red light.
- The Lessee uses the vehicle in restricted areas or roads as outlined in Section 5.

3.4. In the event of an accident, the Lessee must:

- Not move the vehicle.
- Immediately contact the Lessor.

- Call traffic police and record witness information. Obtain a police report for any damage requiring insurance claims, including minor incidents (e.g., hitting a rock). The Lessee must notify the rental company representative immediately and wait for police documentation.

- Take a photo and video of the vehicle & accident place from different angles.

- You will be responsible for paying any official government fines, towing expenses, and costs related to property damage resulting from your involvement in a traffic accident.

3.5. In cases where damage is caused by a third party, the Lessee must contact law enforcement with the Lessor's representative present.

3.6. Insurance does not cover damages due to:

- Negligence by the Lessee, such as using incorrect fuel, ignoring warning lights, or driving in restricted areas and crossing rivers.

- Failure to maintain basic vehicle checks, such as oil, coolant, and tire pressure (2.5 bars recommended).

- Violating any restricted road limitations in Section 5.4, which will result in forfeiture of the deposit.

- Breakdowns and problems as a result of the client's negligence will be charged in full to the client, including any recovery fees incurred.

3.7. The Lessee is liable for damages or the total loss of the vehicle caused by actions outside insurance coverage (such as drunk driving, theft by the Lessee, or unauthorized transfer to third parties).

3.8. In case of total vehicle destruction, the Lessee is liable to pay 10% of the car's value, set at \_\_\_\_\_\_USD.

3.9. The lessee shall be held liable for any damages to the life, health, or property of third parties arising from the use of the rented vehicle, to the extent that such damages exceed the limits of coverage provided under the applicable insurance policy.

3.10. The Lessee is responsible for any harm to themselves or passengers, as well as damage to luggage owned by the Lessee or passengers during vehicle operation.

3.11. Standard fees for non-insured events:

- Lost vehicle registration: 200 USD
- Lost key: 60-90 USD per key
- Tire damage: Replacement cost of 70-100 USD per tire
- Lost/stolen license plate: 60 USD per plate
- Scratches to bumpers or other light damage: Typically \$50-\$100

#### 4. Contract Conditions

4.1. The Lessor provides the vehicle as described. Any discrepancies upon return will justify corresponding deductions from the deposit based on documented expenses.

4.2. The Lessee is responsible for any fines or penalties incurred during the rental period. These must be paid directly to the Lessor.

4.3. The Lessee must return the vehicle in its original condition and configuration, **clean inside and out**, and with a full tank of fuel. **Smoking in the vehicle is prohibited.** Failure to meet these conditions will incur additional charges.

4.4. Late returns are penalized as follows(if the Lessee fails to notify the Silk Way Trips representative in advance):

- Over 30 minutes: 15% of daily rate
- 1-hour delay: 25% of daily rate
- 2-hour delay: 50% of daily rate
- 3-hour delay: 100% of daily rate
- Over 2 hours: The vehicle may be retrieved or reported as stolen.

4.5. Maintenance responsibilities of the Lessee include:

- Oil and Coolant must be checked regularly.
- Tires and tire pressure should be observed regularly.
- Payment of any recovery fees if the vehicle needs towing, etc.
- To avoid outside damage (scratches on the car) it is recommended to park in a closed area.

- Small repairs (up to 100 USD) of a non-critical nature may be performed by the client, but will not be reimbursed without prior agreement by Silk Way Trips.

- Major repairs (over 100 USD) may only be performed with Silk Way Trips' approval.
- Ignoring the instructions of any Silk Way Trips staff or representative will result in the forfeit of the security deposit.
- The client must keep the vehicle locked when not present with the vehicle.

4.6 Breakdowns(where the client is not at fault):

- Breakdowns are an unfortunate part of travel in Kyrgyzstan. If your vehicle breaks down, please notify Silk Way Trips immediately.

- Silk Way Trips will either repair the vehicle or provide an alternative as quickly as possible. If no suitable alternative can be arranged, a refund for the unused rental days will be provided.

- While we strive to resolve issues within 24 hours, please note that roadside assistance services are limited in Kyrgyzstan, and delays may occur. Silk Way Trips is not obligated to refund lost time due to a breakdown but may do so at its discretion.

### 5. Road Limitations

5.1. The following roads are prohibited:

- Altyn-Arashan
- Karakol Gorge (after the last bridge)
- Tosor Pass
- Kegeti Pass
- Ak-Shyrack village
- Road past Kelsuu yurt camp
- 5.2. Types of Roads Permitted for Use (circle):
  - Paved Roads
  - Gravel Roads
  - Dirt Tracks
  - Limited Off-Road Use
- 5.3. You are not allowed to:
  - Cross rivers.

- Drive through challenging off-road conditions.
- Drive recklessly or at high speeds on poor-quality roads( or on unpaved roads).

\*Any violation of road limitations will result in the forfeiture of your deposit. Please note that all our vehicles are equipped with dash cams and GPS trackers.

#### 6. Duration of the Contract

6.1. The contract is valid from \_\_\_\_\_\_ to \_\_\_\_\_ and may be extended by mutual agreement.

#### 7. Responsibilities of the Parties

7.1. Failure to comply with clause 6.1 results in a double rate for each overdue day.

#### 8. Additional Provisions

- 8.1. Any unresolved issues will be handled according to Kyrgyz Republic law.
- 8.2. Changes to the contract must be in writing and signed by both parties.
- 8.3. This contract is in two copies, one for each party, with equal legal force.


