hereinafter referred to as the “Lessee,” on the other side, have entered into this contract on the following terms:

### 1. Subject of the Contract

1.1. Under this contract, the Lessor provides the Lessee with a vehicle for temporary possession and use under the conditions specified below.

1.3. Mileage limit is UNLIMITED.

### 2. Payment

The rental fee is \_\_\_\_ USD per day. Payment can be made in USD, EUR, or KGS (if by cash then make sure the bills are clean, undamaged, unmarked, and in denominations of 50 or higher. Total amount is \_\_\_\_\_

2.2. The security deposit is \_\_\_\_ USD. Part of the deposit will be refunded within three weeks after the rental period, provided all terms are met. However, if the Lessee commits illegal actions involving the vehicle (such as theft, unauthorized transfer, etc.), the deposit will not be refunded.

2.3. Early termination by the Lessee results in a 100% retention of the rental fee by the Lessor.

### 3. Insurance

3.1. The Lessor provides full coverage insurance for the vehicle, with a deductible of **500 USD**.

3.2. The insurance company covers up to **1,000,000 KGS** for third-party liability (life, health, and/or property) in the event of a road incident. You are responsible for any damages to third parties that exceed the limits of the insurance coverage.

3.3. In case of total vehicle destruction, the Lessee is liable to pay 10% of the car's value, set at \_\_\_\_\_.

3.4. Insured events:

- a road traffic accident
- fire and explosion
- natural disasters
- unlawful actions of third parties
- damage caused by a bouncing or falling object — external impact on the insured vehicle (including gravel thrown from under the wheels, stones, and other hard materials), excluding damage to the paintwork without damage to the parts
- theft or hijacking of the vehicle
- other events related to the ownership or use of the vehicle, which occur unexpectedly and originate from external causes

3.5. Non-insured events:

- Proof that the driver was under the influence of alcohol, drugs, toxic substances, or medication that prohibits driving (strict 0.0 limit)
- An accident caused by crossing a solid double line or running a red light.
- Damage to the bottom, tires, suspension, glass, or optics of the vehicle (unless these parts were damaged as a result of an insured event).
- Damage resulting from off-road driving or river crossing (unless caused by an insured event).
- Negligence, such as using the wrong fuel, ignoring warning lights.
- Failing to check and maintain vehicle essentials like oil, coolant, or tire pressure (2.5 bars recommended).

3.6. In the event of an accident, the Lessee must:

- Not move the vehicle.
- Call traffic police and record witness information. Obtain a police report for any damage requiring insurance claims, including minor incidents (e.g., hitting a rock). The Lessee must notify the rental company representative immediately and wait for police documentation.
- Take a photo and video of the vehicle & accident place from different angles.
- You will be responsible for paying any official government fines, towing expenses, or other expenses not covered by the insurance company as a result of the incident.

3.7. The Lessee is liable for damages or the total loss of the vehicle caused by actions outside insurance coverage (such as drunk driving, theft by the Lessee, or unauthorized transfer to third parties).

3.8. The Lessee is responsible for any harm to themselves or passengers, as well as damage to luggage owned by the Lessee or passengers during vehicle operation.

3.9. Standard fees for non-insured events:

- Lost vehicle registration: 200 USD

- Lost key: 60-100 USD per key
- Tire damage: Replacement cost of 70-130 USD per tire
- Lost/stolen license plate: 60 USD per plate
- Scratches to bumpers or other light damage: Typically \$50-\$150

#### 4. Contract Conditions

4.1. The Lessor provides the vehicle as described. Any discrepancies upon return will justify corresponding deductions from the deposit based on documented expenses.

4.2. The Lessee is responsible for any fines or penalties incurred during the rental period. These must be paid directly to the Lessor.

4.3. The Lessee must return the vehicle in its original condition and configuration, **clean inside and out**, and with a full tank of fuel. **Smoking in the vehicle is prohibited.** Failure to meet these conditions will incur additional charges.

4.4. Late returns are penalized as follows(if the Lessee fails to notify the Silk Way Trips representative in advance):

- 1-hour delay: 10% of daily rate
- 2-hour delay: 30% of daily rate
- 4-hour delay: 100% of daily rate (over 3 hours: The vehicle may be retrieved or reported as stolen)

4.5. Maintenance responsibilities of the Lessee include:

- Oil and Coolant must be checked regularly.
- Tires and tire pressure should be observed regularly.
- Payment of any recovery fees if the vehicle needs towing, etc.
- To avoid outside damage (scratches on the car) it is recommended to park in a closed area.
- Repairs may only be performed with Silk Way Trips' approval.
- Ignoring the instructions of any Silk Way Trips staff or representative will result in the forfeit of the security deposit.
- The client must keep the vehicle locked when not present with the vehicle.

4.6 Breakdowns(where the **client is not at fault**):

- Breakdowns are an unfortunate part of travel in Kyrgyzstan. If your vehicle breaks down, please notify Silk Way Trips immediately.

- Silk Way Trips will either repair the vehicle or provide an alternative as quickly as possible. If no suitable alternative can be arranged, a refund for the unused rental days will be provided.

- Silk Way Trips will try to resolve issues within 24 hours, but delays may occur due to limited roadside assistance in Kyrgyzstan. Refunds for lost time due to breakdowns are not guaranteed but may be given at the company's discretion.

#### 5. Road Limitations

5.1. The following roads are prohibited:

- Road to Altyn-Arashan valley(gorge) from Teploklyuchenka (Ak-Su) village
- Karakol Gorge (after the last bridge)
- Tosor Pass
- Kegeti Pass
- Ak-Shyyrak village

- Road beyond Kel Suu yurt camp (only allowed up to the yurt camps in Kok-Kiya valley near Kel Suu lake)

5.2. Rental vehicles may be driven on the following types of roads:

- Paved roads
- Gravel roads
- Limited off-road use (crossing rivers, and extreme off-road driving are strictly prohibited)

\*Any violation of road limitations will result in the forfeiture of your deposit.

## 6. Duration of the Contract

6.1. The contract is valid from \_\_\_\_\_ to \_\_\_\_\_ and may be extended by mutual agreement.

## 7. Responsibilities of the Parties

7.1. Failure to comply with clause 6.1 results in a double rate for each overdue day.

## 8. Additional Provisions

8.1. Any unresolved issues will be handled according to Kyrgyz Republic law.

8.2. Changes to the contract must be in writing and signed by both parties.

8.3. This contract is in two copies, one for each party, with equal legal force.

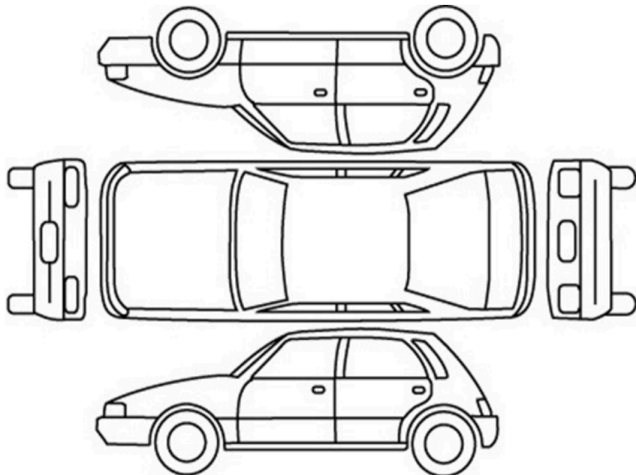
